I am aware of your trust in comitari while visiting the website www.comitari.co where freedom and transparency are important values. It is therefore my responsibility to protect your privacy. On this page I let you know what data I collect when you visit the website www.comitari.co, sign up for the newsletter, subscribe to my mailing service, when downloading a product or leave your details to arrange a session with me. In doing so, you leave your IP address and other personal data. Why I collect this data and how I use it to improve your user experience. So, you understand exactly how I work.

This privacy policy applies to all comitari services . You should be aware that comitari is not responsible for the privacy practices of other sites and resources. By using this website, you indicate your acceptance of the privacy policy.

Comitari respects the privacy of all users of its site and ensures that the personal information you provide is treated confidentially.

About the use of collected data

Use of my services

When you sign up for one of our services, you are asked to provide your personal data. These data are used to perform only that particular service for which you have registered. The data will be stored on comitari's own secure servers or those of a third party. This data is not combined with other personal data in my possession.

Communication

When you send an e-mail or other messages to comitari, those messages are stored. Sometimes I will ask you for your personal data relevant to the situation at hand. This makes it possible to process your questions and answer your requests. The data is stored on comitari's own secure servers or those of a third party. Again, these data are not combined with other personal data in my possession.

Cookies

Comitari collects data for research in order to better understand our customers so that services can be tailored accordingly.

This website uses "cookies" (text files placed on your computer) to help the website analyze how users use the site.

The information generated by the cookie about your use of the website may be transferred to comitari's own secure servers or those of a third party. We use this information to track how you use the website, to compile reports on website activity and to offer other services relating to website activity and internet usage.

This data collection is done in a privacy-friendly manner. The unique customer part of the IP address is anonymized, 'data sharing' is turned off and no combination of other Google services with Google Analytics is used.

However, Google may provide this information to third parties if Google is legally required to do so, or to the extent that these third parties process the information on Google's behalf. I have no influence on this.

Purposes

We do not collect or use information for purposes other than those described in this privacy policy unless we have obtained your prior consent to do so. For example, your data will NOT be resold to third parties.

Third parties

Information will not be shared with third parties outside the company. In some cases, information may be shared internally or with external parties because legislation requires it. Such as an accountant, tax authority, website hosting company, mailing list provider. Accounting program and Google Analytics. Processor agreements are in place with all the aforementioned parties. Employees are also obliged to respect the confidentiality of your data.

Disabling cookies

Most browsers are set to accept cookies by default, but you can reset your browser to refuse all cookies or to indicate when a cookie is being sent. However, some features and services, on our and other websites, may not function correctly if cookies are disabled in your browser.

How long will your data be kept?

No longer than necessary to fulfil the purposes for which the data was collected. Data of both existing clients and prospects are kept for 26 months. Administrative data such as invoices with address details and diary are kept for seven years, as required by the tax law.
